

Window World Warming Hearts & Homes of NEW Giveaway

OFFICIAL RULES

1. Sponsors. This watch and win sweepstakes (“Sweepstakes”) is sponsored by WFRV-TV (“Station(s)”), 1181 East Mason, Green Bay, WI 54301, and Window World of Green Bay, 969 Goddard Way, Green Bay, WI, 54311 (collectively, the “Sponsor(s)”). This Sweepstakes is void where prohibited and is subject to all local, state, and federal laws. By entering, each entrant accepts and agrees to be bound by these Sweepstakes rules.

2. Eligibility. No purchase is necessary to enter this Sweepstakes. A purchase will not improve your chances of winning. This Sweepstakes is open to permanent legal U.S. residents, 18 years of age or older, who reside in AND own a single-family (foundation – concrete/basement/crawl space or pier-based) home in Wisconsin and *within* the WFRV-TV’s viewing area, which includes the following counties Marinette, WI, Oconto, Menominee, Shawano, Waupaca, Outagamie, Brown, Kewaunee, Door, Calumet, and Manitowoc, at the time of entry. Entrants must include their name, address, phone number, e-mail address, date of birth and the *correct* keyword of the day. Keywords, which change each day, will be provided at least once during the Local 5 News broadcasts, scheduled to air weekdays from 6:00 – 7:00 AM CST, 12:00 – 12:30 PM CST, 4:00-4:30 PM CST and 6:00 – 7:00 PM CST, or during the Local 5 Live broadcast, scheduled to air weekdays 9:00 – 10:00 AM CST. As detailed above, entrants must *own* a home within the Station’s viewing area (see details above) at the time of entry and on the dates of the winner selections. Weekday entries must be received by 11:59 PM CST in order to be considered an entry for that day. Incomplete entries will not be eligible to win. All entries must be received by March 15, 2019 at 11:59 PM CST. One (1) entry per person per day will be accepted. Multiple entries will be disqualified.

This promotion includes daily winners, semi-finalist winners and a grand prize winner. Daily winners will qualify to for the semi-finalist random drawing. Semi-finalist winners must be willing and able to attend the finalist/grand prize random drawing scheduled to take place at the Station's studio on Friday, March 29, 2019, between 9:00 – 10:00 AM CST. 5.Prize(s). There will be five (5) winners, including five (5) semi-finalist winners and one (1) grand prize winner, selected from amongst the semi-finalist winners, in this Sweepstakes.

Each weekday at 9:00 AM CST, between March 18, 2019 and March 22, 2019, one (1) semi-finalist winner will be randomly selected from all eligible entries. As detailed above, eligible entries must contain the correct keyword of the day. Each semi-finalist winner will be notified they won by email or telephone and may be announced during the that day's WFRV-TV's Local 5 Live news program, which is scheduled to air weekdays 9:00 AM – 10:00 AM CST. Each semi-finalist winner will receive an opportunity to participate in the grand prize random drawing.

The potential semi-finalist winners will be contacted by a representative of the Sponsors, and must reply within **24 hours** to maintain eligibility.
